This all works fine for usernames, but I am having problems with retrieving images, pathnames, and other database information. The form has a text input box for every field I would need to retrieve. I started by making text input boxes into a table, but ran into other problems: A user entered more than one title in the database, and I cannot have duplicates. I need to be able to validate the database information entered by the user. I have a table of fields in the database with a column for each text input box. So, with one title, the table looks like this: -title_id -username -username_password -email -image_path (text) Then the php code for retrieving the data looks like this: \$title = \$_POST['title_id']; \$username = \$_POST['username']; \$sql = "SELECT * FROM users WHERE title_id = :title_id"; \$query = \$db->prepare(\$sql); \$query->execute(array(':title_id'=>\$title)); \$query->fetch(); The code works fine for usernames, but I have a problem when it comes to retrieving image_path.
